Working hard for Maine people

Budget: Putting Maine's middle class first

Maine families will see tax cuts, property tax relief and increased investment in students and workers under the balanced \$6.7 billion bipartisan budget passed by the Legislature over the governor's veto.

The biennial budget makes smart, targeted investments needed to grow Maine's economy, prioritizes middle-class tax cuts and rejects trickle-down economics. Highlights of the budget include:

Middle-class tax cuts

- Provide a \$135 million tax cut per year for 579,000 Maine families, with 75 percent of the benefit going to the bottom 90 percent of families
- Make the Earned Income Tax Credit refundable up to 5 percent
- Nearly double the standard deduction to \$11,600
- Eliminate the income tax on pensions for military families

Property tax relief

- Double the Homestead Exemption to \$20,000 for all Maine families
- Protect revenue sharing to support local services while keeping property taxes in check and provide \$62.5 million a year for these funds for local communities

Meaningful welfare reform

- Encourage work by fixing the welfare cliff, the sharp drop-off in benefits that occurs as recipients work more and their incomes increase; ensure that individuals in Maine illegally do not receive public benefits

Protection for vulnerable Mainers

- Increase funding by \$16.2 million to help clear waitlists for people with intellectual disabilities and brain injuries

Other laws passed by the Legislature:

Honoring veterans

- Eliminate the income tax on pensions for military families
- Strengthen veterans' services by identifying gaps, inefficiencies and ways to improve them
- Allow Vietnam veterans to receive an existing veterans' property tax exemption their counterparts from other conflicts are able to access
- Provide a gravestone for deceased veterans with no next of kin
- Honor the service of authentic veterans by making false claims of military service a crime

Making education work for young Mainers

- Increase investment in K-12 education by \$80 million and in the University of Maine and Maine Community College systems by \$28 million
- Make college more affordable by investing another \$10 million into the Maine State Grant scholarship program for students and workers
- Provide flexibility in college debt repayment for students and their families
- Make the funding formula fairer and more predictable for public charter schools and local school districts

Increasing public safety

- Create a cold case squad to investigate unsolved homicides
- Fight drug crime by increasing the number of drug enforcement agents, prosecutors and judges as well as creating a drug court in Penobscot County
- Crack down on methamphetamine lab operators and illegal uses of the opioid painkiller fentanyl
- Prevent the abuse of powdered alcohol by banning it in the state
- Strengthen stalking laws, increase protections for domestic violence victims in the workplace and in their homes

Protecting a clean environment, growing clean energy

- Restore funding for energy efficiency efforts to save consumers money and provide predictability to the business community
- Build a comprehensive solar policy so Mainers can reap the benefits of an abundant, clean energy source
- Streamline the approval process to allow the most promising community renewable energy projects to move forward
- Safeguard Maine waters from pollution and protect taxpayers from clean-up costs by defeating weak mining rules
- Protect Maine lakes and local economies by prohibiting the use of certain fertilizers near shorelines

Helping seniors age in dignity and security

- Address the shortage of affordable housing for Maine seniors with a \$15 million bond proposal for housing and weatherization efforts
- Protect the Drugs for the Elderly and Medicaid Savings programs that help low-income seniors pay for medicine and doctor's visits
- Help seniors live independently longer by boosting wages of in-home direct care workers and providing support to family caregivers of elderly Mainers
- Improve the quality of life of homebound seniors with expanded access to Meals on Wheels
- Protect older adults from financial exploitation through a personal finances management program
- Encourage the development of adult family care so seniors can age in place
- Increase funding for nursing homes by \$16 million to \$216 million

Boosting business and the economy

- Help workers learn new skills through expanded access to the Competitive Skills Scholarship Program
- Promote economic development by increasing companies' access to operating capital
- Develop Maine's broadband infrastructure by making grants and technical assistance available to communities
- Send voters an \$85 million bond proposal to invest in roads and bridges
- Put \$1 million into job training for workers
